I have a medical history of life-threatening swelling of vital organs secondary to exposure to radiation and to chemicals and fumes, including life-threatening swelling of heart and brain. Pictures have documented life-threatening rashes and loss of skin and how the swelling inside my skull has been so severe as to push an eye out of its socket.

I have been violently ill several times. At times, I struggle to breathe even with oxigen. I am sleep deprived and in pain all the time. Everyday is a different torture. This is a horrible way to die.

My EHS and CHS have been recognized by federal and State agencies and by Courts as physical medical conditions and as disabilities.

The best treatment for EHS and CHS is avoidance of radiation and of chemicals and fumes.

More than 13 years ago, I lost the ability to drive, to go grocery shopping to be inside buildings and to walk on the streets without aggravating my EHS and CHS. +

I cannot have emergency health care inside a hospital, since the levels of radiation inside hopsitals are more than one hundred times the levels found in other buildings.

(The levels of harmful radiation inside hospitals are millions of times higher that the levels innother places. See Exh. B pages 75, 77b-77d).

To ameliorate the symptoms of my EHS and CHS, including the pain, and swelling and breathing problems I stay in a small metal room and in other places in the backyard, including an underground place.

I use shielding of the thoracic box and shielding of eyes, face, and head most of the time. Most of the time, I use a mask.

I use battery operated detection equipment to measure the levels of radiation reaching my place.

Author's note:

This summary is an expanded section of a larger document entitled "Electromagnetic Health for Children". The full document is designed in response to requests for information detailing current health concerns of electromagnetic fields (EMFs) with a focus on radiofrequency (RF) radiation. This is an expanded subsection covering EHS only.


Background:

We are currently witnessing the largest change to the Earth's electromagnetic environment that has ever taken place in human history. This change has taken place in the very short period of a handful of decades and continues to escalate at an exponential rate (Appendix 1). Given that household electricity, which was the first anthropogenic (man-made) electromagnetic field (EMF), only became prolific after the turn of the century, artificial EMF has barely seen one generation from cradle to grave. The use of higher frequency microwave devices such as mobile telephony, Wi-fi and smart meters, have suddenly become commonplace despite almost no safety testing and decades of evidence of potentially lethal effects. This has sparked a political and scientific debate that is gathering momentum on a daily basis, raising concern about the continued use of such devices. One may assume when witnessing the vast Implementation of, for example Wi-fi in the home, school, workplace or public domain, that experts have provided sufficient evidence of safety to overwhelm scientific concern. This is not the case.

The World Health Organisation (WHO) / International Agency for Research on Cancer (IARC) Classified RF as a Group 2 B 'Possible Human Carcinogen" (2011). Despite this, there has been no attempt in the UK at disseminating this important information to the public. Conversely, it was not even mentioned in the AGNIR government commissioned report a year later in 2012. The only safety guidelines currently used in the UK are those constructed in 1998 regarding 'thermal (heating) effects' of non-ionising radiation. These are not protective of health given the vastly documented non-thermal effect taking place orders of magnitude below these levels. They are obsolete. Other countries have responded to this information and have safety limits more biologically sensible, thousands of times lower than here in the UK (see Appendix 2). Mechanistic data is available to explain these effects and every bodily system is affected (as one would expect from a radiation induced illness).

The very broad range of RF emitting devices on the market were never pre-market safety tested and many now contain fine print warnings from the manufacturers which warn that one must keep the devices a minimum distance from the body which in some cases is incompatible with use. The public are generally not aware of these warnings or the increased vulnerability of certain groups such as children, foetuses, elderly, pregnant women, infirm and those with EHS.

The full paper gives an overview of facts that should be considered during the policy change that is clearly necessary, and this subsection concerns Electromagnetic Hypersensitivity (EHS) only.

Electromagnetic Hypersensitivity (EHS)

A Summary

1. Definition:

Electromagnetic hypersensitivity is characterised by an awareness and/or adverse symptomatology in response to even extremely weak (orders of magnitude below current safety levels^{1,2}) electromagnetic fields of multiple types (in terms of frequency/intensity and waveforms). Relevant diagnostic coding that may be used by UK medical doctors include "idiopathic/environmental intolerance (IEI)", ^{3,4} code Z58.4 (Exposure to radiation) under the International Classification of Diseases (ICD-10), ⁵ T66 (microwave syndrome)="other unspecified effects of external causes: radiation sickness." ⁶

[Note: All life is electrosensitive to some degree and thresholds for conscious perception will vary depending on age, gender and individual physiology. ^{7,8,9,10}]

2. Common symptoms include:

Headaches, dizziness, sleep disturbance, sensory up-regulation, palpitations, unusual pain in multiple sites, visual disturbance, auditory disturbance (esp tinnitus), membrane sensitivity, muscle twitching, dermatological complaints, hyperactivity /fatigue (depends on adrenal status/ state of EHS), restless leg syndrome, memory/concentration disturbance and anxiety 11,12,13,14,15 (psychiatric symptoms such as anxiety and depression are likely to be secondary to the physiological effects rather than a primary cause 16). Interestingly, with good avoidance, symptoms tend to disappear in the reverse order that they accumulated.

3. Characterised by multiple sensory up-regulation:

Up-regulation of all senses is commonly noted in persons with EHS, i.e. Photophobia and/or Scotopic sensitivity syndrome (visual sensitivity), Hyperacusis (hearing sensitivity), Hyperosmia (heightened sense of smell), Hypergeusia (heightened taste sensitivity), Hyperesthesia/Photosensitivity (heightened skin sensitivity) and Multiple Chemical Sensitivity (MCS) is associated. 17,18,99,109

4. Exposure induced:

EHS is a cumulative, exposure-triggered condition, and exposures are rising rapidly (see Appendix 1).

Devices which emit RF and known to cause symptoms in those with EHS Include:
mobile phones, DECT cordless landlines, Wi-Fi/Bluetooth enabled laptop, desktop computers and laptops, Wi-Fi routers, Smart meters, fluorescent lighting, baby monitors, security systems, RFID systems and wireless gaming consoles. ELF (Extremely Low Frequency) fields (household electrical) will also cause symptoms in some individuals.

5. Characterised by increasing trigger susceptibility and irreversibility:

If EHS is unmanaged and there is general deterioration, there will be reaction to an increasingly broad range of frequencies at increasingly low intensities, i.e. the number of devices complained of triggering symptoms will increase and symptomatic distances will decrease. Tendency towards MCS will also increase and irreversibility will become more likely. 20

6. Highly prevalent:

Estimates for the number of people with EHS vary widely, but several countries report around 410%. 21,22,23 In the UK this corresponds to approximately 2.5 to 6.3 million 4 (which is more than the number of UK wheelchair users). This is likely to be a gross underestimation (see point 7 below) given that figures are based on the number of people who have made the connection between their symptoms and EMF exposure. The number of people who have mild EHS symptoms, but have not linked them yet to exposure would be far higher. Given the ubiquity of exposure now in all environments; it can be very difficult for people to notice the association.

7. Rapidly rising:

Extrapolated figures suggest that 50% of the population may be affected by 2017 (Appendix 3).

8. May affect everyone:

Interestingly, the signs and symptoms associated with RF, exposures from e.g. mobile phone base stations, ^{25,26,27,28} ^{29,30,31,32,33,34,35,36,37,38,39,40} (also see Appendix 4) Wi-Fi, ^{41,42} mobile phones, ^{43,44,45,46,47,48,49,50,51,52,53,54,55,56,57,58,59,60,61,62,63,64,65,66,67,68,69,140,143} radio/TV broadcasting transmitters, ^{70,71,72,73,74} smart meters, ⁷⁵ MRI scanners, ^{76,77,78,79,80,81,82,83,84,85,86} and other RF sources ^{87,88} reveal that the general population (not known to be EHS) experience the same constellation of symptoms as are noted in EHS. This is a dose-response relationship. Thus, it is possible that EHS could manifest in all members of the population with enough exposure. (Please note some of the above studies are demonstrating EHS symptoms in children.)

9. Proven physiological condition:

EHS has been demonstrated in a published, peer-reviewed, double blind research study, ⁸⁹ as an 'environmentally inducible bona-fide neurological syndrome', ⁹⁰ and other provocation tests corroborate this evidence. ^{73,76,91,92,93,94,95,101} In addition, multiple papers have demonstrated physiological variations in those with EHS^{25,26,28,31,33,37,92,94,96,97,98,99,100,101,102,103,104,105,106,107,108,109,110,111,112,113} and genetic variations. ⁹⁹ Furthermore, mechanisms are evolving that may explain the symptomatology of EHS. ^{42,44,52,55,56,62,65,69,78,81,87,88,96,100, 114,115,116,117,118,119,120,121,122,123,124,125,126} Therefore, increasingly, professional bodies are recognising this as a physiological condition. ^{127,128,129,130,131,132,133,134,135}

10. Recognised by World Health Organisation (WHO):

The WHO states that 'symptoms are certainly real' and 'in some cases can be disabling'. 136 'Some studies suggest that certain physiological responses of IEI individuals tend to be outside the normal range. In particular, the findings of hyper reactivity in the central nervous system and misbalance in the autonomic nervous system need to be followed up in clinical investigations and the results for the individuals taken as input for possible treatment.' 113

11. Nocebo effect invalid:

Whilst the nocebo effect (physical symptoms induced by fear) has been suggested, ¹³⁷ thorough investigation of individual histories renders this concept invalid in the majority of cases. Additionally, psychological therapies are much less effective at reducing symptoms than avoidance of electromagnetic fields ¹³⁸ (see also point 14 below) and risk perception alone has not been felt adequate to explain the characteristics witnessed. ¹⁷ Furthermore, evidence of EHS type symptomatology in studies involving small children, foetuses ^{139,140,141,142,143} and

animals^{144,145,146,147,148,149,150,151,152,153,154,155,156,157,158,159,160,161,162,163} (where media-cultivated perceptions are impossible), also invalidates this theory.

12. Recognised as a functional impairment:

- Under the disability act in Sweden, 164,165 USA and Canada. 167
- Legal cases are now being won for long term disability pensions/compensation (Australia, 168 France, 169 Spain, 170 UK 171 and United States 172,173).
- Hospital facilities with low EMF have been constructed.¹⁷⁴
- Academic bodies urge immediate protection for those with EHS. 175,176
- The UN^{177,178} and the European Parliament¹⁷⁹ have made clear the requirement for equal opportunities for those with EHS.

13. Notable persons with EHS:

Well known, credible individuals such as Dr Gro Harlem Brundtland, Former Director-General of WHO and the first female Prime Minister of Norway¹⁸⁰ and Matti Niemelä, former Nokia Chief Technical Officer¹⁸¹ have been public regarding their Electromagnetic Hypersensitivity.

14. Medical guidelines for management exist:

Medical guidelines have been drawn up for doctors to diagnose^{95,182} and manage^{183,184,185} the condition physiologically with advice to urgently reduce exposure, and this advice is echoed by many other organizations. ^{164,167,183,186,187,188,189,190,191,192,193,194} Additionally, research has shown avoidance can be the only reliable form of management to improve symptoms. ^{138,195} Currently the most reliable way to diagnose EHS is via history, i.e. it is a clinical diagnosis, ¹⁸² but there are other tests currently being used in the private sector and in the research forum believed by their users to be diagnostic or aid diagnosis.

15. Children have EHS:

Many children are currently affected, but undiagnosed. Children are likely to be more vulnerable to developing EHS since their exposure is higher (as explained above), and outcomes may be worse given their developing systems and greater time for latent effects. Children with EHS must be supported at school under the conditions stated in the 'Supporting pupils at school with medical conditions' Department for Education document (April 2014). 196

16. Vulnerable groups and white zones:

In addition to those with EHS and children, other vulnerable groups include the elderly, pregnant women, foetuses and those with co-morbidity (concurrent) illnesses. In order to protect vulnerable groups there has been increased call for designated, legally protected white zones (no or low EMF areas). 197,198,199

17. Socioeconomic impact of EHS and human rights:

It has been demonstrated that EHS is already affecting a very large number of people in the UK (see point 6) and given that a proportion of these people will be unable to work due to their condition, avenue is being lost. Additionally an extra burden is created on NHS resources due to inappropriate assistant management of common symptoms, including in those who may be unaware they have

ore severe cases, individuals are forced to live in extreme isolation, poverty and poor health.

Juals cannot access basic, life sustaining public amenities, such as grocery stores, petrol

and health care facilities. There is therefore a clear breach of their human rights. We are aware

All EHS persons require 'comprehensive health evaluation':

"Because of the huge socioeconomic impact anticipated for EHS worldwide, the World Health Organization has devoted considerable attention to EHS, acknowledging this condition and recommending that people self-reporting sensitivities receive a comprehensive health evaluation". 201

Author's notes:

I am contacted on a daily basis by a variety of different individuals including, persons with EHS, medical practitioners, school and parent groups, legal representatives, media and political bodies in the UK looking for medical advice on EHS or health effects of EMF in general. This is an increasingly demanding task and therefore I have founded a medical doctors organisation entitled PHIRE (Physicians' Health Initiative for Radiation and Environment) in order to increase the available support for those requesting it. PHIRE aims to:

- 1. Create an academic programme for the education of medical practitioners to improve understanding of EMF related health effects.
- 2. Construct British medical guidelines for diagnosis and management of EHS.
- 3. Advise educational groups regarding protection of children from EMF exposure.
- 4. Increase awareness and support for adults and children with EHS and other vulnerable groups. >
- 5. Expand current British research teams, and use global connections to maintain state-of-the-art of education.
- 6. Open constructive dialogue with DOH (Department of Health)/PHE (Public Health England).
- 7. Advise on best practice public guidance.

during the month of October 2019 and after detection equipment showed
increases of radiation at my place. During the Summer of this year, I
suffered the same symptoms including rashes and loss of skin on my neck
and on the upper back which made my skin thick and leather like.
(similar to pictures I and 2, attached herein.)

At times, I feel the flashes of radiation in real time, specially when I am lying down; during crisis; and when the rashes break my skin. I take this opportunity to provide some detail to the progressive aggravation of my EMS and CMS.

During the last days of March 2011, I lost the ability to drive and the ability to be inside buildings even for short periods of time. With exception of some walks around the neighborhood during the year 2011; a 2-block walk on the year 2016; and few, brief walks to the neighbords? yards, I have been homebound since March 30, 2011. I cannot stay inside my home but for a few minutes at a time, and I stay in a small metal room and in other places in the backyeard.

To ameliorate the symptoms of my EHS and CHS I use shielding of the thoracic box and shielding of eyes most of the time, and at times, I use shielding of head, gloves and a face/gas mask.

I have been violently ill several times. At times, I struggle to breathe even with oxigen. At several times, increases of radiation and/or chemical odors have made me collapse and to pass out. At times, I spend hours laying down with extreme weakness and fatigue. Changes in level's of radiation and/or chemical odors do not allow me to stay in the same place for extended periods of time, and I have to change bed places even at night. I am sleep deprived and in pain all the time. This is a horrible way to die.

I have not been self-dependent for many years. Others sook for me and make my errands. At times, I work on cars in the backyard, and in most cases, I make less than \$100 per month. For years, I have tried to 64g: bigger my sunken place. However, at times I spend weeks and even months without the ability to dig. I spend weeks without the ability to type on a mechanical type writer due to my loss of concentration. My speech and concentration problems are making very difficult to advocate for myself. To make things worse, despite that KHS and CHS are reaching opidemic proportions. Green professionals struggle to understand the legitimacy and seriousness of EHS and CHS. Thank-you for being an Angel.







The Administrative Law Judge issued a decision on April 4, 2017. The claimant has asked the Appeals Council to review this decision.

The Appeals Council grants the request for review under the substantial evidence provision of the Social Security Administration regulations (20 CFR 416.1470). Under the authority of 20 CFR 416.1477, the Appeals Council vacates the hearing decision and remands this case to an Administrative Law Judge for resolution of the following issue:

The decision finds the claimant does not have a medically determinable impairment, in part, because his diagnosis of electro-sensitivity disorder is not recognized by the medical community. The claimant's doctor diagnosed this impairment and submitted evidence of signs, symptoms and laboratory testing (Exhibits 3F, 4F, 5F and 6F). In October 2014, the claimant's doctor noted he has been homebound for three years and has many symptoms from electric field exposure including systemic problems and skin reactions with blood pressure variations (Exhibit 3F, page 2). In May 2015, the claimant's doctor indicated the best treatment for the claimant's condition is to avoid all radiation, which causes him to be homebound. At the same time, the claimant was prescribed portable oxygen due to difficulties with breathing related to his impairment (Exhibits 4F and 5F). Laboratory testing from 2008 indicates abnormalities in auto immune functioning (Exhibit 6F, pages 63-66). The claimant submitted laboratory tests from 2013, which may also show additional abnormalities (Claimant Submitted Evidence pages 116-117). Further, consultative examiner Dona E. Cooper-Dockery, M.D. indicated that, while rare, the condition is recognized in the medical community (Exhibit 1F, page 8). Finally, the State agency consultants did not have the full record when determining there was insufficient evidence to find a medically determinable impairment. As such, further consideration of whether the claimant has signs, symptoms and laboratory testing to confirm a medically determinable impairment based on his electro-sensitivity disorder is needed.



Survey in 2011

In the Final Results Summary, the four clusters of symptom's with the fewest responses (2 to 5 percent each, totaling 13 percent) were included in "Other" but are broken out separately in the above bar graph, reducing the responses listed as "Other" (from 31 percent to 18 percent).

Summaries of Symptoms after Exposure to Wireless Utility Meters

People from coast to coast in the USA, and from one side of the world to the other, are becoming ill after exposure to the radiofrequency radiation emitted by wireless utility meters. Attached are the results from three surveys of symptoms reported in 2011, 2013, and 2014.

The Survey in 2011 included 318 respondents from 28 states in the United States, and from Canada. The Survey in 2013 included 210 respondents from 33 states in the United States, from Canada, and from Australia. The Survey in 2014 included 92 respondents from the other side of the world, Victoria, Australia. Altogether, 620 adults and children were included in the three surveys.

The attached bar graphs show the number of respondents in each survey who experienced new or worsened symptoms after exposure to the radiofrequency radiation from wireless utility meters in the respondents' environment. Each bar indicates the percentage of respondents who experienced each symptom. Respondents commonly experienced multiple symptoms. Each bar graph is followed by one page of additional information written by the person who analyzed the survey data for the Survey in 2011 and the Survey in 2014, or by me for the Survey in 2013.

The three surveys were conducted independently. They grouped symptoms into somewhat different categories, but many of those categories are similar enough to be comparable. Of the nine most frequently experienced categories of symptoms in each of the three surveys, seven appeared in all three of the surveys: insomnia; headaches; ringing in the ears; cognitive disturbances affecting concentration, memory, or learning; dizziness or loss of balance; cardiac disturbances such as heart palpitations or arrhythmia; and fatigue or weakness. Insomnia was the most frequently experienced symptom in all three of the surveys.


The surveys do not tell us how likely a given individual is to become symptomatic after exposure to the radiofrequency radiation from wireless utility meters. But the surveys do tell us which symptoms a person who does become symptomatic is most likely to experience. The large numbers of symptoms found reflect the many systems of the body that are disrupted by such radiation.

Other health effects may not be as easily sensed by the body as those represented by the symptoms described here. The development of these other health effects may go undetected for years. Examples include reproductive harm, DNA damage, and cancer.

Executive Summary by Ed Halteman, Ph.D. "Wireless Utility Meter Safety Impacts Survey"

OBJECTIVES

- To investigate reported public health and safety complaints about wireless utility meters.
- To evaluate the impacts on health and safety due to wireless utility meters.
- To determine whether further study is warranted.

METHODS

- Survey was designed by the EMF Safety Network (Network).
- The survey was circulated online through various social media outlets including Network's email list, Facebook, and the California EMF Safety Coalition (a discussion group).
- The survey was also posted on Network's website: www.emfsafetynetwork.org where visitors were invited to take the survey.
- 443 responses were received from 7/13/2011 through 9/2/2011. (318 of the 443 answered the health questions that formed the basis for the bar chart on symptoms. RMPowell)
- Network commissioned Survey Design and Analysis (SDA) to provide this report of the survey findings.

RESPONDENT MAKEUP

- 93% are over 40 years old and 43% are over 60 years old.
- 73% are women.
- 78% are from California.
- 68% have Pacific Gas and Electric (PG&E) as their utility provider.
- 49% are EMF Sensitive.
- 41% have had a new wireless meter installed in their home; of these . . .
 - o 56% have had it installed for at least six months
 - o 89% have electric meters, 53% gas meters and 10% water meters
 - o 35% saw an increase in their utility bill
 - o 26% have experienced some type of interference
 - 8% experienced burned out appliances or damaged electronics including TV, stereo, computer, refrigerator and other.
- 76% indicated they have wireless utility meters installed in their neighborhood, town or city.
 - o 44% near their home
 - o 36% in town

TOP HEALTH ISSUES SINCE NEW METERS INSTALLED

- Sleep problems (mentioned by 49%)
- Stress, anxiety and irritability (43%)
- Headaches (40%) (Listed as 41% on symptoms bar graph, rounded up from 40.9%. RMPowell)
- Ringing in the ears (38%)
- Heart problems (26%)


UTILITY and PUBLIC UTILITY COMMISSION INTERACTIONS (Title inserted by RMPowell.)

- 40% (111 people) of those having wireless meters in their homes or community have complained to their utility provider.
 - o 96% of these people were either "Unsatisfied" or "Very Unsatisfied" with the handling of their complaint.
- 32% (88 people) complained to the utilities commission.
 - o 96% of these people were either "Unsatisfied" or "Very Unsatisfied" with the handling of their complaint
- 94% of respondents want to retain or restore their analog meters and 92% of these respondents do not think they should have to pay any additional money.

Survey in 2013

Abstract of "Smart Meter Health Effects: Survey and Report" by Richard H. Conrad, Ph.D. and Ed Friedman, B.S.⁴

Purpose of Survey

This survey was designed to discover the health effects experienced by individuals exposed to smart meters, and to test the strength of the correlation between those effects and that exposure. The survey was distributed widely through internet sites and interest groups with this invitation: "If you feel your health has been affected by smart meters, we request your immediate help in studying these effects." The results of the survey were submitted as legal testimony before the Maine Public Utilities Commission in 2013.

Survey Respondents

Survey data was collected from December 4, 2012 to January 28, 2013. 210 survey documents were completed and used for analysis. About 75 percent of respondents were from the USA, with the rest from Canada and Australia. 73 percent were women. 52 percent were age 45 to 59, while 29 percent were older and 19 percent were younger. The highest academic degrees, and the number of respondents with them, were BS or BA (70), high school (61) or GED (4), MS or MA (42), PhD (9), MD (1), RN (1), DDS (1), and other medical (13).

Exposure of Respondents

83 percent of respondents were exposed to at least 1 smart meter that was 4 to 50 feet from where they spent the most time. Within 50 feet of their residences, 39 percent were exposed to 1 to 2 meters; 32 percent to 3 to 5 meters; 12 percent to 6 to 9 meters; and 11 percent to 10 to 29 meters. Such high exposure may explain why the percentages of new or worsened symptoms in this survey were higher than in the 2011 and 2014 surveys.

Timing of Exposure versus Timing of Symptoms

After smart meter installation or start of exposure, new or worsened symptoms were experienced within minutes for 20 percent of respondents, within hours for 14 percent, within days for 28 percent, and within months for 19 percent. Yet 42 percent did not discover that they had a smart meter until **after** new or worsened symptoms began. 82 percent of respondents were sure, and 17 percent were fairly sure, that their new or worsened symptoms correlated to smart-meter exposure. 17 percent moved and 37 percent wanted to.

Impact of Exposure on Respondents' Use of Other Wireless Devices

This survey assessed the impact of exposure to smart meters on the respondents' ability to use other electronic devices that also emit radiofrequency radiation: computers, Wi-Fi, and cell phones. Exposure to smart meters significantly reduced the respondents' ability to use those other electronic devices without symptoms.

Computers: The percent of respondents who used computers without symptoms was 79 before exposure and decreased to 39 after exposure. The percent of respondents who experienced symptoms when using computers was 21 before exposure and increased to 57 after exposure. The percent of respondents who did not use computers at all because of symptoms was 0 before exposure and increased to 2.4 after exposure.

Wi-Fi: The percent of respondents who used Wi-Fi without symptoms was 40 before exposure and decreased to 18 after exposure. The percent of respondents who experienced symptoms when using Wi-Fi was 11 before exposure and increased to 28 after exposure. The percent of respondents who did not use Wi-Fi at all because of symptoms was 17 before exposure and increased to 41 after exposure.

Cell Phones: The percent of respondents using cell phones without symptoms was 50 before exposure and decreased to 24 after exposure. The percent of respondents who experience symptoms when using cell phones was 18 before exposure and increased to 39 after exposure. The percent of respondents who did not use cell phones at all because of symptoms was 14 before exposure and increased to 26 after exposure.
