On the year 2018, a federal investigation detailed how Texas school district were maliciously concealing the hundreds of thousands of children with disabilities.

Despite that a federal investigation found that Greg Abbott broke the law to conceal massive disability discrimination against children, Abbott's malicious attempts to conceal these atrocities continue unaddressed, undeterred and with impunity. Evidence on the record details how Greg Abbott in collusion with the U.S. Dept. of Education are trying to unload the millions of children that became disabled by the microwave radiation at school into private schools, which have no academic accountability or transparency and which have no duty to protect disabled children under the Americans with Disabilities Act and under the Rehabilitation Act.

Dr. Josef Mengel, "a doctor of unfathomable perversity", like the doctors without expertise in EHS/CHS and other harm caused by low levels of microwave radiation and other environmental toxicants, disguised himself as a serious man of science.
