

PARENTS ALERT (Dec. 2024)

++ EHS is also known as Microwave Sickness and CHS is also known as Multiple Chemical Sensitivity or MCS.

- 4- That the symptoms and signs caused and aggravated by exposure to INVISIBLE, SILENT AND UNPERCEIVED wireless/microwave radiation and to chemicals and fumes commonly found on the environment MIMIC AND ARE CONFOUNDED WITH SYMPTOMS AND SIGNS OF MOST ILLNESSES, INCLUDING HEART ATTACKS AND STROKES and of other catastrophic, irreversible and deadly illnesses;

(THIS IS LIKE TRYING TO EXTINGUISH A FIRE WITH GASOLINE)
- 7- THAT MILLIONS OF CHILDREN WHOSE BRAINS AND BODIES have been injured and disabled by the massive exposures to wireless/microwave radiation and to chemicals and fumes at school are further VICTIMIZED by mass mis-medication and isolation and even institutionalized and INCARCERATED LIKE CRIMINALS IN GUANTANAMO-LIKE PRISONS;
