## COMPLAINT OF CRIMINAL VIOLATION OF CONSTITUTIONAL AND STATUTORY RIGHTS.

Specific, concrete and undisputed medical, scientific and legal evidence on the record of federal and State Courts has proven conclusively as a matter of fact and as a matter of law the collusion of the Governor of Texas, Greg Abbott with:

- 1- U.S. District Chief Judge, Randall Crane:
- 2- U.S. District Judge, Ricardo H. Hinojosa;
- 3- U.S. District Judge, Micaela Alvarez;
- 4- With U.S. Attorney Alamdar S. Hamdani;
- 5- With the U.S. Dept. of Education and the Commissioner of the Social Security;
- 6- With other federal and State agencies and prosecutors;
- 7- And with members of the Judiciary and others:
- 8- In tampering and falsification of government records; in fabrication of testimony and of statements and in fabrication of medical evidence:
